LETTER FROM The President

Dear Centerville-Washington Foundation Supporters,

The Foundation has weathered the many changes during this pandemic and it is because of your financial support that we have been able to respond to the critical needs of our community. Once the COVID-19 situation began, we proactively investigated the urgent needs of our community and identified two non-profit organizations that were addressing what the Foundation felt were needs of paramount importance: *ensuring that children, seniors and those with mental health challenges would not go hungry*. The Board provided two emergency Community Grants (\$5,000 each) to Food2Go and Shoes 4 the Shoeless to assist their efforts in these areas.

In early March, prior to the lockdown, the Foundation had named the following organizations as beneficiaries of this year's *Community Support Grants* (totaling \$20,000) so they could continue their important work in the Centerville/Washington Township community: The Castle, Centerville Band Boosters, Centerville-Washington History, Girls on the Run, Heart of Centerville and Washington Township, Incarnation Conference-St. Vincent de Paul, Learning Tree Farm, Ronald McDonald House, SICSA, and The South Dayton Dance Theatre.

The Centerville-Washington Foundation, as a component of The Dayton Foundation, remains steadfast and responsive to the needs of our community. While we are in excellent financial condition, we welcome your important donations and reinvestment in our community. Our mission depends on your support. We hope to be able to meet with you again at our annual *Founders event on October 1, 2020*, at Yankee Trace Clubhouse, if not in person, then virtually, as we honor historic preservationist Martha Boice. And, again, thank you for your support and confidence in the Centerville-Washington Foundation. We seek to put the funds of our supporters to work in our community, making a difference for all.

\$2,000 to The Incarnation Conference, St. Vincent de Paul, for Emergency Vehicle Maintenance and Repairs.

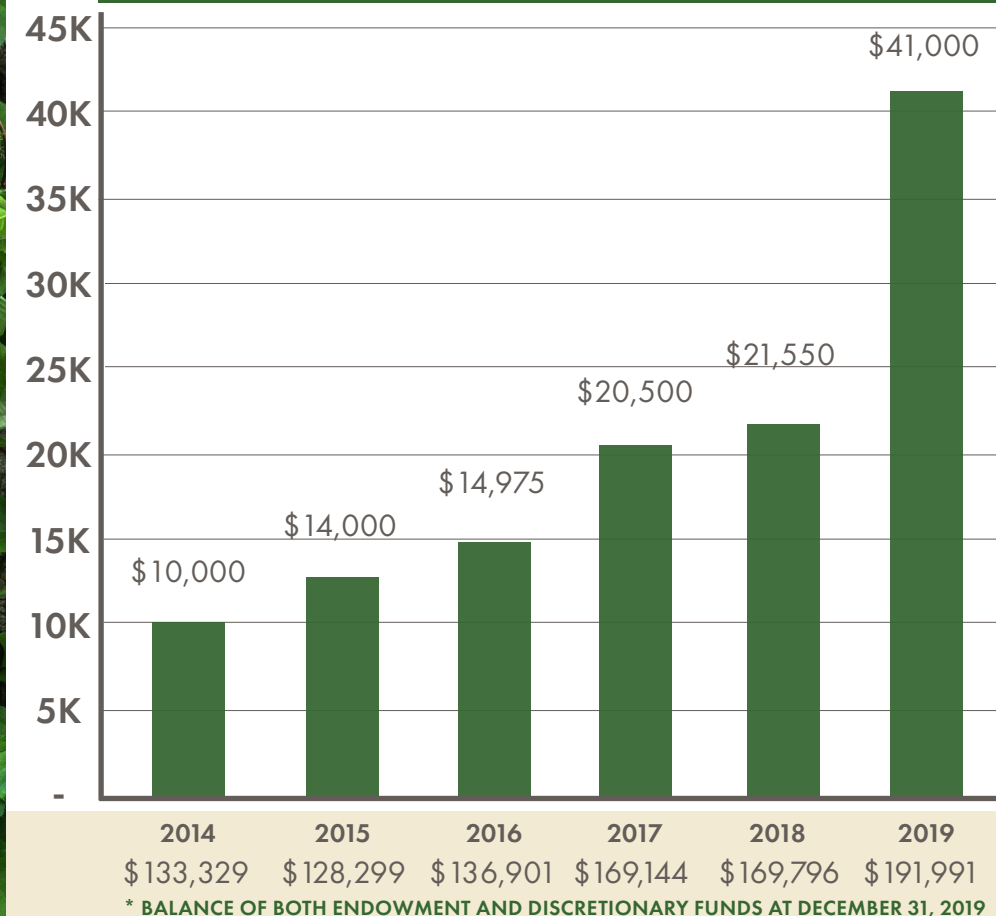
\$2,000 to South Dayton Dance Theatre for The Nutcracker Ballet Backdrops Project.

FINANCIAL REPORT Grants Awarded



AGAIN WE CAN'T THANK OUR DONORS ENOUGH. Even though we distributed a record amount in grants in 2019, we continue to grow both the discretionary and the endowment balances of the Foundation to record levels. Certainly we had some good results from our investments, but your response to our efforts is having a real impact in the money available to help folks in our community. Because of the growth in available funds your board has approved a budget for 2020 that once again will include distribution of grants at record levels.

Two Community Impact Grants were given in response to support the needs during this Global Pandemic. The organizations that received emergency funding from The Centerville-Washington Foundation are:
